AUTHORIZATION AND RELEASE OF LIABILITY

I, the parent or guardian of an enrolled child, authorize the participation of my child in the FutureSTRONG Academy (herein being referred to as FS) program (the "Program") of the above-named Academy.

FOOD

I hereby release FutureSTRONG Academy, its office and employees, from any and all liability related to the contents, preparation, and presentation of food, prepared or purchased for any events associated with the Academy.

MEDIA

CONSENT TO MEDICAL TREATMENT

In the event my child is injured or becomes ill in Program activities, and if I, the parent or guardian of the above-named child, am not present to make medical decisions, I hereby authorize the Academy, its staff, volunteers including volunteer parent participants, coaches, assistant coaches, and referees, supervisors and drivers, to arrange for and consent on my behalf to emergency medical and dental care and treatment, including tests and radiological exams, and surgery, and hospital care and treatment, and to consent to medications for pain and other conditions as prescribed by medical personnel attending my child. I am responsible for payment of any medical charges or expenses not covered by my insurance or the insurance applicable to my child (if any). My signature below indicates that all information provided in this form is true and accurate, and that I fully agree to all statements made on the form, including but not limited to the Authorization and Release of Liability, Medical Conditions, and Consent to Medical Treatment. My signature also indicates that all legal guardians are aware and consensual with the participation of the above-named child.

- Terms & Conditions, Fees and Policies are subject to change without prior notice.
- Make Checks payable to FutureSTRONG Academy.
- Registration Fee and Program Fee (semester) once paid are NOT refundable.
- The program fee is NOT based on the number of attendance days in each month and NO refunds/adjustment made for missed sessions, holidays or center closing.
- \$30 will be charged for Cancelled or Returned checks.
- The child needs to be re-registered, if absent or temporarily withdrawn from the program for more than 90 days.
- The center reserves the right to replace or combine the students from one batch to another as well as split, merge batches.
- The center reserves the right to request removal of the child if they're perceived to be a threat to the wellbeing or the smooth operation of the camp.
- Grade sheets will be provided to the parents, and the Answer sheets will NOT be shared.
- The child will receive a red sticker when they do NOT bring classroom aids such as pencil and eraser to the class. The students can borrow classroom aids when they forget to bring, however if not returned, the cost of the classroom aid(s) will be charged separately.
- The teacher or instructor will discuss the progress with the parents periodically. The Parents are encouraged to consult with the teacher or instructor to find if the student requires a make-up session if the student missed a class or catch-up session if the student is falling behind or joined late.
- Parents are requested to sign the workbook your kids bring home after a session. This is mainly for the Parents to know how their kids are doing.
- The parents are required to drop and pick-up the children inside the center/after school program and also need to sign-in/out at the reception.
- The classroom will be opened 5 - 10 minutes before session. The Parents are required to ensure that the students attend all the classes, report into the classroom 5 minutes before the session and complete all the given homework, assignments before the beginning of next session.
- We give 1 hour classes per session and it's the parents responsibility to pick up the kids on time.
- Missed sessions can't be repeated while we have different subjects per session.
- Parents, guardians and students may not use or transmit FS materials, methodologies or content for any new or existing business venture or STEAM enrichment programs. A violation of this clause would allow FS to seek a temporary restraining order and other damages from the appropriate court.
